If the membership approves the Board recommendation to have a second MAL, nominations for that position will be received and the election held at the February meeting.

A second business issue for our January meeting is to seek approval of the membership to raise our annual dues to \$20 effective with year 2002 memberships. Round Table operational expenses are minimal, but costs have increased over the past years and dues have not. The Board unanimously supports this recommendation and I urge you to support it as well.

I will be spearheading a membership drive as a high priority this year, but in the main, my goal is to just have more "hustle and bustle" around the Round Table at the end of the year than we have now. I invite you to call me with comment or suggestions at any time. See you on **Wednesday, January 31st at 7:00 p.m.** at the **Sudwerk Bar and Grill**.

Unfortunately, our scheduled speaker, Eric Ericson, will not be able to join us so Carol Breiter will step in and broaden our understanding and knowledge of General Hooker. A Tempest at Tea-time

It is commonly assumed that the batteries on Alcatraz Island never fired a shot in anger during the Civil War, but like most assumptions, it is not quite true. The canon on Alcatraz did lob a shot across the bow of a warship, thereby precipitating a minor diplomatic flap – a tempest at tea-time, as it were.

The incident began about noon on the first of October 1863. Her Majesty's Ship *Sutlej*, the flagship of Rear Admiral John Kingcome, commanding British naval forces in the Pacific, sailed into San Francisco Bay and made ready to anchor off Sausalito. The arrival of this vessel aroused the suspicions of Captain William Winder, Third Artillery, commandant at Alcatraz. Usually the revenue cutter *Shu-brick* guarded the Golden Gate, ascertaining the business of visiting warships. This particular day, however, she was at Point Reyes assisting a Russian corvette that had gone aground.

Port regulations required that in such an event the land commander make the determination, but there being no wind, Captain Winder could not readily identify the flag being flown by the H.M.S. *Sutlej*. The boats available to him for calling on ships entering the bay had departed to meet other vessels. Furthermore, Captain Winder knew Sausalito to be an unusual anchorage for visiting ships and had heard the rumors of Confederate privateers operating along the Pacific Coast. He, therefore, decided to compel the unknown visitor to heave to and identify herself by firing a blank round in her direction. When this failed to produce the desired effect, he ordered a shotted round sent across the mystery ship's bow.

The local press reported that the ball skipped across the water about 200 to 300 yards from the H.M.S. *Sutlej*, splashing her with spray. Whether or not this dampened Admiral Kingcome's uniform is not known, but it did prompt him to begin firing what Captain Winder presumed to be a salute to the American flag. From his vantagepoint, though, he could not tell how many guns were being fired. When Captain Winder at last learned that an American flag, indeed, was flying from the ship's mast-head, he hastily ordered the firing of a 21-gun salute in return, followed by a similar salute from Fort Point.

This should have ended the matter, but that afternoon, Admiral Kingcome penned a letter to Brigadier General George Wright, commanding the Military Department of the Pacific, and California's governor Jon G. Downey. Piqued at the fact that a round had been fired in the direction of his ship, he protested the incident and called for an inquiry. General Wright responded two days later that he had asked Captain Winder for a report, but "beg[ed] to inform" the admiral of the port regulations that required land officers to stop and examine vessels entering the bay before they passed the forts. In an equally civil reply, Admiral Kingcome asserted that he had not been aware of the port regulations and expressed his indignation that, "no acknowledgement has been offered for this disregard of the courtesies usually extended toward the ships of war of all friendly nations."

By this time, General Wright was beginning to lose patience with the admiral, but he did not wish to ruffle further the feathers of the representative of neutral power, particularly one that could damage the Union's war effort if it chose to recognize the Confederacy. He wrote yet another letter expressing regret that a formal exchange of salutes had not occurred. Since, "this pleasant interchange of official courtesies between the high officers of friendly nations has a tendency to strengthen the bonds of friendship and the maintenance of a good understanding between their respective Governments."

By the time General Wright drafted this letter, however, the H.M.S. *Sutlej* had departed San Francisco Bay so he sent it in care of the British consul. No reply was forthcoming from Admiral Kingcome. In his report to the Adjutant General, General Wright defended his actions and those of his subordinate, stating, "It has always been a pleasure for me to treat foreign officers visiting our country with the greatest courtesy and respect." He placed blame for the incident on the British, whose unusual actions and disregard for port regulations had made Captain Winder suspicious in the first place.

It had been a tempest at teatime, indeed, but one that illustrated the tensions present on the West Coast and the strained relations between the United States and Great Britain at the height of the Civil War.

Summary of Proposed Changes To the Bylaws

In order to reduce the amount of time that we spend on business matters at our upcoming Wednesday night meeting, I ask you to review this summary of proposed changes to the SCWRT bylaws. Should you desire to look at the complete current bylaws and compare to the complete proposed bylaws, copies of both will be available in the meeting room on Wednesday night. I will be asking the membership for a motion and second to accept the proposed changes. Your Board of Directors unanimously recommends these changes and urges their acceptance.

The proposed changes are minor and are essentially of three types: (1) one change is proposed to make the bylaws consistent with current operating procedures (2) one change has been previously approved by membership vote and the change merely updates the written document, and (3) the new issue is to add a second Member-at-Large to the Board of Directors. A brief discussion of these changes follows:

- (1) The current bylaws state that announcements of meetings must be at least seven days prior to the meeting time. For at least the last three years, the Battle Cry has been mailed to arrive four or five days ahead of the meeting rather than "at least seven days." This practice gives a reminder of the upcoming meeting closer to the meeting time and that timing has proven to be more effective. It also gives slightly more time between the monthly board meeting and the mailing for the Battle Cry Editor.
- (2) The membership voted last fall to hold the "annual meeting" that elects the incoming slate of officers in October rather than in January as the bylaws had specified. This added planning time for the new officers provides a smoother and more effective transition. This change to the written document merely reflects current policy.
- (3) A second member-at large would give the opportunity for more of the membership to be directly involved in board activities. This seems like prudent action in a growing organization. A practice of nominating relatively "new" members to this position would be encouraged. This would improve the balance of the board membership by providing new oversight and fresh ideas. The change would also call for giving the members-at-large primary consideration when selecting round table members to chair committees. The second member-at-large would be a voting member of the Board of Directors. No member may simultaneously hold more than one board position.

I view these proposed changes as important in a technical way, but of minimal practical significance. I welcome your thoughts and comments (530-886-8806) and request your support of these changes. See you on Wednesday night! Thanks.
